You will be given a registration tag or collar and a receipt. **If your animal requires microchipping** you are required to take your animal and registration receipt to Animal Control at the Works Department at 9am on a Thursday for microchipping. The animal must wear the tag or collar provided.

**WANDERING ANIMALS**

All animals found to be wandering through the community will be collected by the Animal Control Officers and placed in the pound. Owners will have 5 working days to collect their animal and pay any registration and/or impound fees to Council.
